## Purpose & Scope

Logan Aluminum, Inc. (Logan) is dedicated to responsible handling of emergency situations, and as such maintains plans to ensure proper response to various scenarios. These plans are summarized in The Emergency Action Plan.

The Emergency Action Plan aims to achieve three primary goals:

- Minimize injuries and illnesses to personnel during emergencies.
- Minimize damage to the facility and the environment.
- Return to normal operations as quickly as possible.

To ensure effective implementation, all Logan Aluminum employees receive Emergency Action Plan training during annual Mandatory Training. New employees receive:

- A general overview addressing plant emergencies.
- A unit-specific safety orientation addressing unit-specific concerns.

Logan Aluminum is also committed to alliance with the Aluminium Stewardship Initiative (ASI), and as such is committed to specific goals surrounding Emergency Response, including transparency (Section 2.7 of ASI Performance standard). This plan is an abridged version of the Logan's Emergency Action Plan Program, which redacts any proprietary information about plant operations. The full plans which provide the necessary detail for internal operation are located in Logan's Document Control system.

## **Response Protocols**

Logan maintains resources on-site to respond to emergency situations quickly. This includes onsite firefighters/ HAZMAT, onsite EMT, onsite security, onsite contractors for spill response, and onsite nursing staff.
